#### **ORDINANCE NO. 374-2019**

### AN ORDINANCE AMENDING PARKING RATES AND LOCATIONS IN THE CITY OF CAPE MAY

#### **MOTION:**

#### **SECOND:**

**WHEREAS**, Chapter 7 of the Cape May Municipal Code regulates traffic and parking in the City; and

WHEREAS, Section 7-44.3 of the Cape May Municipal Code designates metered public parking areas in the City, and Section 7-45.3 regulates parking at the City's Bank Street parking lot; and

WHEREAS, the Municipal Parking Advisory Committee appointed by City Council pursuant to Resolution 135-05-2018 has submitted a report to City Council that recommends certain changes in the metered parking rates and locations in the City; and

WHEREAS, having reviewed that report, City Council believes it to be in the best interest of the City and its residents to modify the metered parking rates and locations in the City to increase parking supply, better accommodate parking demand, assist City businesses and enhance the experience of visitors to the City,

**Now, THEREFORE BE IT ORDAINED** by the City Council of the City of Cape May in the County of Cape May and State of New Jersey as follows:

- **SECTION 1.** Section 7-44.3 and Section 7-45.3 of the Cape May Municipal Code are hereby repealed in their entirety.
- **SECTION 2.** There are hereby established in the City "Parking Meter Zones" in accordance with the attached map, incorporated into this ordinance.
- **SECTION 3.** Except as set forth below, metered parking hours in the City shall be as set forth of the attached map.
- **SECTION 4.** The parking meter rate in the "red" and "yellow" zones on the attached map, and in the Jackson/Perry Street city parking lot ("purple" on the map) shall be \$2.00 per hour, or 50 cents per 15 minutes. The parking meter rates in the "green" and "orange" zones on the attached map shall be \$1.00 per hour, or 25 cents per 15 minutes.
- **SECTION 5.** Parking on Beach Avenue east of Philadelphia Avenue, and on any side streets off Beach Avenue east of Philadelphia Avenue shall be free after 5:00 p.m., whether or not the spaces are metered.

**SECTION 6.** The parking of motor homes, trailers, and campers is prohibited in the Jackson/Perry Street parking lot.

**SECTION 7.** Permits to park at the City's Bank Street Parking Lot shall be available on a year-round basis. No heavy equipment of any kind, whether owned by the City, its contractors, or otherwise, shall be parked in the Bank Street lot at any time.

**SECTION 8.** All other ordinances in conflict or inconsistent with this Ordinance are hereby repealed, to the extent of such conflict or inconsistency.

**SECTION 9.** Should any section, paragraph, sentence, clause or phase of this Ordinance be declared unconstitutional or invalid for any reason, the remaining portions of this Ordinance shall not be affected thereby and shall remain in full force and effect, and to this end the provisions of this Ordinance are hereby declared to be severable.

**SECTION 10**. This Ordinance shall become effective 20 days after final passage and publication, according to law.

# CALENDAR YEAR 2019 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14

**MOTION:** 

SCOND:

**WHEREAS**, the Local Government Cap Law, <u>N.J.S.A.</u> 40A:4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A:4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

**WHEREAS**, the City Council of the City of Cape May in the County of Cape May finds it advisable and necessary to increase its CY 2019 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and.

WHEREAS, the City Council of the City of Cape May hereby determines that a 3.5% increase in the budget for said year, amounting to \$135,338.20 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS the City Council of the City of Cape May hereby determines that any amount authorized hereinabove that is not appropriated, as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

**NOW THEREFORE BE IT ORDAINED**, by the City Council of the City of Cape May, in the County of Cape May a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2019 budget year, the final appropriations of the City of Cape May shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 1.0%, amounting to \$448,566.27 and that the CY 2019 municipal budget for the City of Cape May be approved and adopted in accordance with this ordinance; and,

- BE IT FURTHER ORDAINED, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,
- **BE IT FURTHER ORDAINED**, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,
- BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

**Now, THEREFORE, BE IT RESOLVED** by the City Council of the City of Cape May, County of Cape May that in accordance with N.J.A.C. 5:30-7.6a & b and based upon the Chief Financial Officer's certification, the governing body has found the budget has met the following requirements:

- 1. That with reference to the following items, the amounts have been calculated pursuant to law and appropriated as such in the budget:
  - a. Payment of interest and debt redemption charges;
  - b. Deferred charges and statutory expenditures;
  - c. Cash deficit of preceding year;
  - d. Reserve for uncollected taxes;
  - e. Other reserves and non-disbursement items;
  - f. Any inclusions of amount required for school purposes.
- 2. That the provisions relating to limitation on increases of appropriations pursuant to N.J.S.A. 40A:4-45.2 and appropriations for exceptions to limits on appropriations found at 40A:4-45.3 et seq. are fully met. (Complies with "CAP" law.)
- 3. That the budget is in such form, arrangement, and content as required by the Local Budget Law and N.J.A.C. 5:30-4 and 5:30-5.

- 4. That pursuant to the Local Budget Law:
  - a. All estimates of revenue are reasonable, accurate, and correctly stated;
  - b. Items of appropriation are properly set forth;
  - c. In itemization, form, arrangement, and content the budget will permit the exercise of the comptroller function within the municipality.
- 5. The budget and associated amendments have been introduced, publicly advertised, and adopted in accordance with the relevant provision of the Local Budget Law, except that failure to meet the deadlines of N.J.S.A. 40A:4-5 shall not prevent such certification.
- 6. That all other applicable statutory requirements have been fulfilled.

**BE IT FURTHER RESOLVED** that a copy of this Resolution be forwarded to the Director of the Division of Local Government Services.

WHEREAS, the Cape May County is home to the United States Coast Guard Training Center Cape May ("TRACEN Cape May"), which is the fifth largest Coast Guard base in the world and the nation's only Coast Guard recruit training center, and which also houses tenant commands engaging in missions such as vessel support, participation in air/sea rescue, investigative services, communications and homeland security services; and

WHEREAS, after several levels of Coast Guard flag review and approval, and confirmation by the United States Congress, Cape May County has been awarded the designation of "Coast Guard Community," a distinction awarded to only one other county in the United States; and

WHEREAS, the designation of "Coast Guard Community" will endure for five years, at which time it shall be reviewed by the Coast Guard to determine whether it should be renewed for another five-year term; and

WHEREAS, the Coast Guard's involvement in Cape May County dates back over a century to that of its predecessor, the United States Life-Saving Service, with a significant ensuing presence in multiple towns throughout the County – ranging from the small life-saving stations that graced our coastlines before the advent of advanced search-and-rescue technologies, to the historic North Wildwood Lighthouse tended for decades by Coast Guard keepers, to the Woodbine Uniform Distribution Center where uniforms and accessories such as service medals are shipped to Coast Guard bases around the world, to TRACEN's massive modern presence on 352 acres of land and coastline within the City of Cape May, with a complement of more than 850 full-time military and civilian personnel and a graduation rate of more than 4,000 recruits yearly; and

WHEREAS, Coast Guard families have become an integral part of our County's rich fabric as our family, our neighbors and our friends, participating in our interdependent "Cape economy" and engaging in daily activities that provide powerful steppingstones, as well as memories, for our futures; and

WHEREAS, Cape May City in particular has had a special relationship with the Coast Guard through many collaborative efforts such as, without limitation, supporting the Coast Guard Enlisted Memorial Foundation, joint mutual aid for fire and rescue services, a proclamation of Coast Guard Day on August 4<sup>th</sup> of each year, joint participation in various parades and civic events honoring Memorial Day, Patriot's Day and Veterans Day, as well as other community events, and attendance by the Mayor and Council at various events at the Training Center; and

WHEREAS, on June 20, 2016, the Cape May City Council adopted Resolution 144-06-2016, in which it affirmed its support for the Cape May City Post Office, but opposed any attempts to alter the façade of the Post Office Building; and

**NOW, THEREFORE, BE IT RESOLVED,** by the City Council of Cape May as follows:

- 1. The averments of the preamble are incorporated by reference.
- 2. The City of Cape May re-affirms its lengthy and honored relationship with the United States Postal Service and pledges to continue its long history of full and unwavering support for the United States Post Office building in Cape May.
- 3. The Council also wishes to make clear, however, that it supports handicapped accessibility at the Post Office to the extent such accessibility is possible and feasible under federal and state law, in that such accessibility would allow the Post Office building to better serve the residents of and visitors to the City of Cape May.
